TERMS & CONDITIONS:

Bids shall be accepted under the "two stage bidding process" defined in the rule 36(c), Public Procurement Rules 2004, which is as follows;

"At first stage, the bid will consist of a technical bid only, without any reference to prices, but including a list of any deviations to the technical and commercial conditions set forth in the bidding documents and/or adding any alternative technical solutions a Bidder wishes to offer, and a justification thereof, always provided that such deviations or alternative solutions do not change the essential requirements specified in the bidding documents. At second stage the bidders whose technical proposals or bids have not been rejected and who are willing to confirm their bids to the revised technical requirements shall be invited to submit a revised technical proposal incorporating all required changes issued subsequent to the first stage bidding and the financial proposal." Further details can be seen in the Tender Documents.

A complete set of Tender Documents can be purchased by interested bidders on payment of a Tender Fee i.e. Rs.1000/- (non-refundable) up to June 18, 2008 during office hours. A pre-bid conference which potential bidders may attend will be held on May 27, 2008.

All bids must be accompanied by an Earnest Money of Rs.250,000/- in favour of Karachi Fisheries Harbour Authority in the form of Pay Order or an irrevocable Bank Guarantee from any scheduled bank of Pakistan. The bids without Earnest Money will not be considered and rejected.

Bids shall reach the office of Managing Director, Karachi Fisheries Harbour Authority on June 19, 2008, by 1300 hours. Bids will be opened on the same day at 1400 hours in the presence of bidders or their representatives who may wish to be present.

The bidders not registered with Sales Tax and Income Tax Registration authorities will not be considered and their offer will be rejected as non responsive.

The Karachi Fisheries Harbour Authority reserves the right to accept or reject any or all bids without assigning any reason thereof.
